THE POLICE COMMISSIONER IS HOSTING A PROMOTION CEREMONY ON FEBRUARY 09, 2022. ACCORDINGLY, THE FOLLOWING PERSONNEL WHO ARE BEING PROMOTED AND ARE IN COMPLIANCE WITH DEPARTMENT VACCINATION GUIDELINES, ARE DIRECTED TO REPORT AT 0730 HOURS WITH THEIR I.D. CARD TO THE POLICE ACADEMY, LOCATED AT 130-30 28TH AVENUE, FLUSHING, NY, ROOM PT-110. ALL PROMOTEEES ARE TO ENTER AT THE WEST SIDE ENTRANCE ON COLLEGE POINT BOULEVARD AND IN ACCORDANCE WITH OPERATIONS ORDER 32, S.21, WILL BE PROVIDED WITH PERSONAL PROTECTIVE EQUIPMENT UPON ENTERING. UNIFORMED MEMBERS BEING PROMOTED SHALL APPEAR IN DRESS UNIFORM AND WILL NOT CHANGE THEIR INSIGNIA OR UNIFORM RANK UNTIL THE CEREMONY HAS CONCLUDED.

ALL PERSONS IN ATTENDANCE AT DEPARTMENT PROMOTION CEREMONIES WHO ARE TWELVE (12) AND OLDER MUST PROVIDE PROOF OF VACCINATION AGAINST COVID-19 TO GAIN ENTRY. ALL ATTENDEES-INCLUDING MEMBERS OF THE SERVICE AND THEIR GUESTS-MUST HAVE RECEIVED AT LEAST ONE DOSE OF A TWO-DOSE COVID-19 VACCINE, SUCH AS PFIZER OR MODERNA, OR A SINGLE DOSE OF A SINGLE-DOSE COVID-19 VACCINE, SUCH AS JOHNSON & JOHNSON. ANYONE WHO CANNOT SHOW PROOF OF VACCINATION STATUS WILL NOT BE ALLOWED ENTRY INTO THE EVENT, WITH THE EXCEPTION OF MEMBERS OF THE SERVICE WHO HAVE AN APPROVED REASONABLE ACCOMMODATION. A GOVERNMENT-ISSUED VACCINATION CARD, A SMARTPHONE PHOTO OF A GOVERNMENT-ISSUED VACCINATION CARD, THE NEW YORK STATE EXCELSIOR PASS, AND/OR THE NYC COVID SAFE SMARTPHONE APPLICATION WILL BE ACCEPTED AS PROOF OF VACCINATION.

ALL ATTENDEES WHO ARE TWO (2) AND OLDER WILL ALSO BE REQUIRED TO WEAR A FACE COVERING WHILE INDOORS. CHILDREN UNDER THE AGE OF TWO (2), HOWEVER, WILL NOT BE REQUIRED TO WEAR A FACE COVERING INDOORS.

MEMBERS OF THE SERVICE WILL STILL BE PROMOTED IF THEY ARE UNABLE TO ATTEND THE CEREMONY.
